Notice of Race (NOR)

[NP] denotes a rule that shall not be grounds for protests by a boat. This changes RRS 60.1 and 63.2(a).

1. RULES

- 1.1 The regatta is governed by the rules as defined in The Racing Rules of Sailing (RRS).
- 1.2 No national prescriptions apply.
- 1.3 If there is a conflict between the Notice of Race and the Sailing Instructions, the Sailing Instructions will take precedence.
- 1.4 [NP] The penalty for a breach of a class rule may, at the discretion of the protest committee, be less than disqualification.

2. SAILING INSTRUCTIONS

- 2.1 The sailing instructions will be displayed on the ONB located at the veranda on the date.

3. COMMUNICATION

- 3.1 The official noticeboard (ONB) is located on the RVYC Veranda.
- 3.2 [DP] From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data transmissions that are not available to all boats, including via mobile phones.

4. ELIGIBILITY AND ENTRY

- 4.1 The regatta is open to RVYC members and their invited guests in the following separate classes:
 - Hobie 16/Dart 18 Class
 - Other Multihulls Class

5. FEES

- 5.1 No entry fee.

6. SCHEDULE

7. VENUE

- 7.1 Racing will take place in the waters immediately off the Royal Varuna Yacht Club.

8. COURSES

- 8.1 The courses to be sailed will be long-distance courses around islands and navigation buoys.
- 8.2 Courses and starts will be detailed in the Sailing Instructions and at race's briefing.



9. PENALTY SYSTEM

9.1 For multihulls, RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

10. SCORING

10.1 RVYC handicap system shall be in place. See Attachment 1.

11. PRIVACY INFORMATION

11.1 By registering for the race, You allow RVYC to use your personal information, including photographs, for administrative, instructional and safety purposes. You also agree that RVYC may share photographs of you with you and the other participants of your course and within the RVYC community, including on our social media. If you do not wish to have your photograph shared, please notify our reception when you register. RVYC will never use your personal information or photograph for advertising without your prior permission.

12. LIABILITY AND INDEMNIFICATION

12.1 The Organizing Authority and all their officers, members and volunteers do not accept liability for loss of life or property, or personal injury or damage caused by or arising out of the event. Competitors take part in the event at their own risk.

12.2 The establishment of the notice of race and the sailing instructions in no way limits or reduces the complete and unlimited responsibilities of competitors being solely and entirely responsible for the management of their boats before, during and after the championship.

12.3 Competitors shall maintain their boats in a safe and seaworthy condition.

12.4 A competitor shall be of good health and a competent sailor capable of racing the dinghy in open water in all conditions, including strong winds.

12.5 At-fault occurrences to other boats are the responsibility of the competitor. Competitors are not covered by any liability insurance provided by the organizing authority and should provide their own coverage for personal goods and liability protection. The organizing authority recommends that competitors consult their own insurance carriers to ensure they are covered at this event and regarding additional personal liability insurance coverage.

12.6 A competitor is advised to have personal accident and health insurance that covers him while attending the event and while racing.

12.7 To the fullest extent permitted by law, each competitor agrees to indemnify and hold, the Host, organizing authority, owners, affiliates, officers, employees, agents, members, volunteers, committee persons and race officials, acting in their official capacities, harmless from any claim arising from a competitor's acts or omissions.
